Intimation about the Medical Fit / Unfitness of the Candidates

1. Document verification (DV) for the post of JE/DMS/CMA under CEN No. 03/2024 was conducted at this RRB from August 2025 to January 2026. Candidates whose DV was successful were sent for Medical examination at the nominated Railway Hospitals/ Health Units across Southern Railway Jurisdiction.
2. Candidates whose Medical fitness have been declared by Railway Medical Authority can view his/her medical standard on the link provided in the website of RRB/Chennai.
3. The following candidates who have been found unfit in the prescribed medical category for the post of JE/DMS/CMA, have the option to prefer an appeal to the Principal Chief Medical Director (PCMD), Southern Railway, Chennai.

4. Candidate who desires to prefer appeal against the decision of the Railway Medical Authority may submit the same, with relevant documents to **The Chairman, Railway Recruitment Board, No.5, Dr. P.V. Cheriau Crescent Road, (Behind Ethiraj College), Egmore, Chennai - 600 008 before 18.00 hours of 27.04.2026**. They should submit the appeal by Speed Post only. **Belated appeal, if any, will be summarily rejected.**
5. **After attending DV, those candidates who have absconded / absented willfully for Medical Examination are not eligible for an appeal.**
6. **Earlier, the medical status of the candidates was published through website of RRB/CHENNAI on various dates, based on which Notices for preferring Medical appeals were also published. Those who did not prefer Medical Appeal against such notifications or whose appeal has been rejected are not eligible to apply for Medical Appeal in this notification.**

Procedure for Appeal

The appeal will be entertained only if: -

1. The candidate produces a certificate in the attached prescribed format (**Annexure-A**) from a Government/Private Doctor of the specialty/specialties in which the candidate has been found unfit.
2. Such certificate should contain a note that the Government/Private specialist is fully aware of the physical and visual standards set by the Railways for the particular medical category, and that he is aware of the fact that the candidate has already been declared unfit according to these standards during medical examination conducted by an appropriate Medical Board.
3. The certificate should bear the photograph and mark of identification of the candidates duly attested by such a Government/private medical issuing authority duly mentioning MCI/State registration number.
4. Candidate will be required to pay **Rs.1000/- (Rupees One thousand only)** through Demand Draft payable in favor of **FA&CAO / Southern Railway, Chennai**.
5. Where PCMD is of the opinion that there should be re-examination of the case of appeal, he may nominate a Medical Board to re-examine the candidate. The decision of PCMD, Southern Railway on the appeal preferred by the candidates will be communicated to them through RRB/Chennai.
6. On appeal, if the decision changes from unfit to fit, the amount of Rs. 1000/- submitted through DD, will be returned to the candidate. In all other cases, the DD amount will be forfeited and the candidates will not have any claim on the same.
7. After this appeal, no further chance will be given for medical examination.

Note: Appeal against the medical unfit should be sent in his / her own handwriting with signature. The format of specimen appeal is given as Annexure-B. The appeal will be entertained with the appeal letter (Annexure-B), Annexure-A & DD for Rs. 1000/- only.
